In this process, a buyer or developer purchases all units within a condominium property and removes the property from the provisions of the condominium regime, often converting the property into apartment rentals. Considered by many in the industry to be the leading authority in the deconversion process, Kelly is a regular guest speaker and panelist for various industry lectures, seminars, and panel discussions. Notably, Kelly has recently been featured in a number of leading Chicago publications on this topic, including the Chicago Tribune, Crain's Chicago Business, the Chicago Gazette, and The Real Deal. Kelly has been a frequent lecturer for Strafford Publications on the topic of deconversions from 2022-2025.
